

# ***Taos Invites Taos 2008 Exhibition Jewelry Entry Form***

TAOS FALL ARTS FESTIVAL (TFAF) Sept. 26, thru Oct. 13, 2008

## **INFORMATION SHEET - PLEASE READ CAREFULLY**

This exhibition will be hosted by the Taos Fall Arts Festival, a 501(c)(4) corporation, at the Taos Convention Center Exhibition Hall - 120 Civic Plaza Drive, Taos, New Mexico.

### **LIABILITIES AND RESPONSIBILITIES**

The TFAF and/or The Convention Center (Town of Taos) will not be responsible for loss or damage of any artwork, no matter what the cause. By submitting artwork to this exhibition and signing this contract, each artist agrees to these conditions. Artwork is not insured while in the possession of TFAF and The Convention Center (Town of Taos). The TFAF Committee has final decision rights to exhibit or decline any entries for any reason.

By entering the show, you agree that you have read and will abide by all rules outlined in this entry form and in your acceptance letter. If you enter the exhibition, you agree that the artwork entered will be available for the exhibition if it is accepted. If, after you submit your entry and sign this agreement, you have the opportunity to sell the painting and wish to take advantage of that opportunity, the proper course of action is to send the 40% commission to the TFAF when you deliver the artwork to the buyer. **Failure to abide by any rules or requirements in this prospectus may result in your disqualification from future TFAF exhibitions. NO SUBSTITUTIONS OF ARTWORK WILL BE ALLOWED. However, if your artwork is sold during the exhibition, you will be asked to replace it with one piece of artwork in the same category.**

### **ABOUT THE EXHIBITION JUDGES AND AWARDS**

**The names of the judges will be announced when they are chosen.** All awards in each category will be based upon the merits of the artwork as judged. It is possible that not all categories will be given an award if the awarding judges feel that there is no suitable winner in any given award category. The judges' decisions are final. **Entries in the Miniature Category will not be judged.**

### **EXHIBITION ARTWORK REQUIREMENTS FOR JEWELRY CATEGORY**

- An artist may submit up to 10 pieces of jewelry.
- **Jewelers must provide their own lockable display cases and stands.**
- All work must be original and must not have been previously exhibited in retail or for-sale situations. All artwork must be an original produced by the submitting artist within the last twelve months.
- All work must be for sale at the normal gallery price, and "Not For Sale" items will not be accepted.
- **Absolutely NO mechanically produced art of any kind, will be accepted.**
- Jewelry artists will receive 70% of the retail sales price and the TFAF will receive 30% as a sales commission. Buyer contact information will be provided to the artist with payment after completion of the exhibition.
- Since buyer will be allowed to take the art home upon purchase, one replacement piece will be allowed. For art purchased that has received an award, we ask buyers to leave the art for the duration of the show if possible. For sold artwork that has received an award, the artist will be allowed to bring in one piece of artwork in the same category.

### **REQUIREMENTS FOR JEWELRY DISPLAY CASES AND STANDS**

Artist must provide their own gallery suitable stand and display case. The case must be lockable and a key must be left with TFAF upon delivery of artwork. The key must have the artist name and phone number attached.

## **ART CATEGORIES**

2008 TAOS FALL ARTS FESTIVAL

### ***TAOS OPEN, TAOS INVITES TAOS AND THE LIVING MASTERS EXHIBITIONS***

**REPRESENTATIONAL PAINTING & DRAWING:** Wet and dry media. Works created in oils, acrylics, watercolor, washes applied by pen or brush, pastels, chalk, charcoal, pencil and wax crayon are all in this category. All work must be dried and ready to display. Wet art will not be accepted. All work must be original. Reproductions are prohibited.

**CONTEMPORARY PAINTING & DRAWING:** All abstract/non-objective artwork in wet and dry media. Works created in oils, acrylics, watercolor, washes applied by pen or brush, pastels, chalk, charcoal, pencil and wax crayon are all in this category. All work must be dried and ready to display. Wet art will not be accepted. All work must be original. Reproductions are prohibited.

**MIXED MEDIA:** Combinations of varied art media within one art piece in 2-dimensional and 3-dimensional form.

**CERAMICS:** All original clay and porcelain works, other than jewelry, are acceptable in this category. All work must be original. No forms of mass production are permitted.

**GLASS:** All original glasswork, other than jewelry, is acceptable in this category. Glass entries include both 2- and 3-dimensional works where glass is the main emphasis. Stained, blown, slumped, cast, and kiln-formed glass will be accepted in this category. All work must be original. No forms of mass production are permitted.

**REPRESENTATIONAL PHOTOGRAPHY:** All photographs taken with any type of camera or digital capture. Includes photographic prints made using either traditional darkroom or digital printing methods. Must include a single recognizable subject and may have had minor aesthetic alterations such as removing unwanted elements, reflections, and the like. All artwork must be framed or gallery wrapped and ready to hang.

**ABSTRACT PHOTOGRAPHY:** All photographs taken with any type of camera or digital capture. Includes all photo-montage images. All work where the artwork as a whole does not have a single recognizable subject or where elements are repeated. All artwork must be framed or gallery wrapped and ready to hang.

**FIBER:** All work crafted from fibers. This includes basketry, embroidery, weaving, leatherwork, tapestry, beadwork and paper. No machine tooling, machine-screened patterns or other forms of mass production are permitted.

**FURNITURE:** Handmade, one-of-a-kind items only. No production work is allowed.

**GRAPHICS AND PRINTMAKING:** Printed works in which the artist's hand has manipulated the plates, stones, etchings or screens and then properly signed and numbered them as a limited edition. Monotypes, serigraphs, wood and linoleum block prints are included in this category.

**JEWELRY:** Includes all jewelry or body adornment. Metal, glass, clay, fiber, paper, plastic or other materials are included in this category. Lapidary work, lost wax, and sand-cast items are also included. All work must be an original piece. No forms of mass production are allowed.

**MINIATURE:** (Invite and Masters Only, not judged) Artwork must be from one of the listed categories and includes both 2-D and 3-D work. 2-D art must have no more than 14"X14" outside framed dimensions, and sculpture may be no more than 8" tall, excluding the base.

**SCULPTURE:** Three-dimensional original work done in any media. Non-religious bultos are also in this category. Works in wood, stone, metal, bronze, composites, fiberglass, carving, modeling, welding, and assemblage are included.

**DEVOTIONAL ART:** Santos, bultos, retablos, relief carvings, icons and any art which has a religious theme or focus.

**KIDS' ART:** Only in the Open Show and not judged. These are entered by kids and displayed on a special wall.

I also affirm that my artwork has been created during the past 12 months. If artwork is sold during the exhibition, one piece of artwork in the same category will be delivered by the artist ready for hanging.
